Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2021-22 educational progress for Bronson Jr./Sr. High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. If you have any questions about the AER, please contact the Jr./Sr. High School Principal John Herbert for assistance.

For the 2021-22 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2021-22. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2021-22. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2021-22. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school was identified as "NOT BEEN GIVEN ONE OF THESE LABELS."

One of the biggest challenges we have is maintaining our high graduation rates. This requires a great deal of hard work on the part of our students and educators. Fortunately, we will once again have our May Term program going this year and this will help our students complete their credits. Our most recent "4-Year Adjusted Cohort Graduation Rate (2021)" is 88.89%. Our long term target (2025) is 94.44%.

Currently, we are reviewing supports for ELs, as their proficiencies continue to be lower in comparison to non-ELs. Also, continued discussions are taking place regarding PBIS systems to improve student behavior, in turn increasing student achievement.
